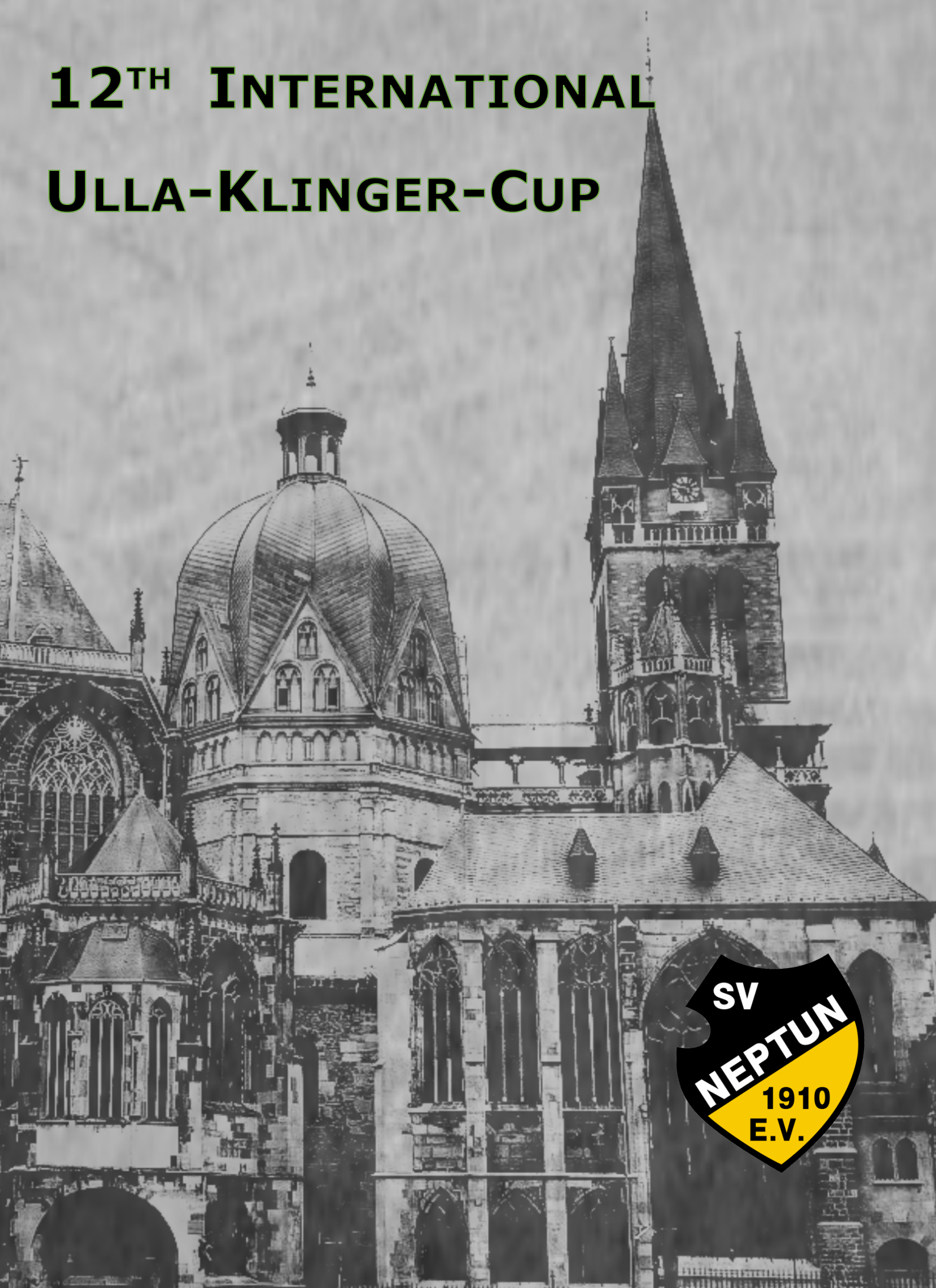

COSTS

Sync competitions: €20 per start/per diver

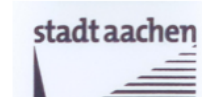
DIVE LISTS

All dive lists have to be entered electronically via DiveRecorder. This link <https://www.diverecorder.co.uk/onlinesheets/index.php> takes you to the input page. Please use the "Select Meet" button to select the 12th International Ulla-Klinger-Cup. Then enter the data of the athlete and save it. The dives will be entered in the corresponding competition. If the entry is incorrect, the program marks the incorrectly entered dive. After completing the entry of an athlete, you will receive a confirmation email.
